The North Carolina Association of Women Attorneys Judicial Endorsements Committee announced its 2022 judicial candidate endorsements today. The Committee makes non-partisan endorsements in judicial races only. The Committee endorses a candidate for judicial office based on his or her legal skills and ability, professional competence, legal experience, temperament, and demeanor as befits a judicial position. Other factors considered include the candidate's demonstrated support for the participation of women in the legal profession and for the rights of women under the law.

"We have carefully researched the judicial candidates we have endorsed, and we are confident each of them will make excellent judges," said Rachel Blunk, a Greensboro attorney who is the Committee's chair.
